Sir/Madam,

1. With reference to above cited subject, you are informed to check the status regarding period of recognition of your School on Board's **website: www.gbshse.gov.in**.
2. While uploading data pertaining to your institution through online webportal designed for first time/continuation of recognition of institution, it is informed to maintain following documents for the perusal of inspecting panel.
 - (i) Copy of permission letter from Director of Education, at the time of First Time Recognition.
 - (ii) Details of staff available, accommodation, furniture, equipments, strength of the school, awards obtained by the school or students at various levels State, district etc, different types of registers, result sheets etc.
 - (iii) All documents pertaining to the data uploaded through online webportal for recognition.
3. Needless, to mention the norms circulated vide prevailing circulars shall be strictly followed by the institutions while applying for first time recognition.

I. First Time Recognition /Additional Subjects for Secondary and Higher Secondary Schools

- (i) The Secondary Schools/Higher Secondary Schools applying for the First Time Recognition shall apply as per Form – I and for Additional subjects as per Form – II, which is available on the official website of this Board, accompanied by Copy of permission letter from Directorate of Education Porvorim-Goa.
- (ii) The application form should also enclose Advice Note ` F ' and PRE – RECEIPT signed by the Secretary about the details of the payment towards recognition.
- (iii) The School shall obtain provisional index number from the Board's office and thereafter upload institutional information with photographs minimum five from different angles to get clear view of particular items through Webportal designed for recognition of institutions under Goa Board once the link is opened. The link for session 2019-20 will be opened during last week of July and will remain open till end of August.
- (iv) **The payment shall be as under:**
 - i) ₹ 500/- processing fees
 - ii) ₹ 1500/ Inspection fees
 - iii) ₹ 200/- incase of additional subject

II. Continuation of Recognition in respect of Secondary Schools/Higher Secondary schools and Continuation of Additional subject(s)

1. The Schools applying for First time Recognition / Continuation of recognition shall apply as per Form-I and for Additional subjects as per Form-II available on the official website of this board.
2. The school shall submit Form – I / Form – II as per schedule.
3. The School shall upload the institutional information with photographs minimum five from different angles to get clear view of particular items through Webportal of Goa Board once link is opened and the inspecting team of the concerned taluka for respective schools shall verify the information uploaded by the school.
4. The Higher Secondary Schools shall upload the institutional information with photographs minimum five from different angles to get clear view of particular items through Webportal designed for recognition of institution once the link is opened and the appointed inspection panel shall verify the information uploaded by the Higher secondary schools.

5. (i) It may be noted that recognition in additional subjects will not be granted if the additional subject is directly introduced at class X/XII. The recognition in additional subjects shall be sought by the school for introducing those subjects, initially at class IX/XI and subsequently at class X/XII in a phased manner.
- (ii) It is also informed that the Institutions introducing additional subjects/courses should apply for the recognition of Board after getting permission from the Directorate of Education latest by June of the concerned year. Recognition of the Board to additional Subject/ course is formality and be taken for granted.
- (iii) Recognition to additional subject (s) shall be granted as per circular No.50 dated 17/08/2007.

III. The permission to change name of the School/Higher Secondary School and name of the of Management shall be requested with the following documents:

- i) Permission from the Director of Education, Porvorim.
- ii) Required fees.
- iii) Undertaking.

It is enjoined upon all Heads to follow Rule No.5 (14) of Goa, Board of Secondary and Higher Secondary Education Board Rule, 1975 regarding the change in Management. The same is required to be strictly adhered to.

3. 21/06/2019 (Sanguem, Quepem, Sattari, Canacona)

V. The High Schools which fail to apply for continuation of recognition within the stipulated date will be levied fees that include normal fees plus 50% of the registration fees, up to **21/05/2019**. Whereas, For **Higher Secondary schools** this fee will be up to **24/06/2019**. Thereafter application shall be treated as time-barred with normal fees plus 50% of registration fees plus ₹ 20.00 per day till the date of submission of the application form.

VI. Incomplete application will not be accepted and such application submitted later beyond the time schedule will attract levied fees as above.

VII. It may be noted that the applications of candidates for admission to S.S.C. /H.S.S.C. Examination sponsored by the **unrecognized Schools under this Board will be rejected without mentioning any reason.**

All fees should be remitted by one Crossed D.D. Only.

- (ii) **Payment can be made by E.C. S** only through **Central Bank of India** from any branch in Goa with a narration mentioning the name of School.

- (iii) The fees will be accepted from **(Time: 10.00 a.m. to 1.00 p.m at Board's office and 2.00 p.m to 4.00 p.m at Central Bank of India Porvorim) .**

- (iv) Cash above ₹ 2000/- shall not be accepted at the Boards office, however the same should be deposited in the Central Bank of India, from any Branch in Goa.

- (v) All the Secondary and Higher Secondary Schools shall collect the enrollment fees at the time of admission of students in class IX and XI respectively. In case of fresh admissions at class X and XII from other states or from other Boards the enrollment fees shall be collected accordingly. No enrollment fees shall be collected from repeaters admitted from the same school or from other Schools recognized by this Board whose one time enrollment fees have been already collected.

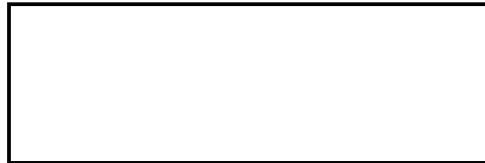
